I, the entrant hereby acknowledge the following:

Entry fee is \$50 for creativewilmington.com current members; \$80 for non-members (includes one year membership). Registration fee is non-refundable.

The entry fee is to pay for the tables and advertising. You will be given a space approximately 8'x8' which will include a banquet table that is six feet wide and thirty inches deep.

All art sales are my responsibility. Art for the Masses, CreativeWilmington and all of its affiliates take no commission.

All sales should be priced between \$25 and \$250. No two for \$25, three for \$25, etc. If you do not follow this rule, you will not be allowed to participate in future events.

There is no guarantee of sales.

I am responsible for the table issued to me, and will return it in the same condition in which it was given to me. If it is damaged, I agree to pay full replacement value.

Table display should be setup on Friday November 20th between 2-5pm. I am expected to be COMPLETELY set-up by 5pm.

Out of respect for the event and all those participating, I am expected to stay through the duration of the event.

In order to promote fairness, table assignment will be based on the order applications are received.

The display of my artwork is my responsibility. (i.e. boxes, shelving, price tags, signs, etc.)

Chairs are not supplied (feel free to bring your own)

Food is not provided (feel free to bring your own)

Expect customers to need change. (Bring a small amount of change for ease of sales)

In regards to the property - if I damage it, I pay for it.

I hereby knowingly and voluntarily agree to waive all liability for injuries to my person or property, for myself and my heirs and assigns, arising from my presence in or use of the Premises.

The Released parties include CreativeWilmington, its Board members, agents and volunteers, as well as any landlord of the Premises, owner of the Premises and agent thereof. The consideration for this Waiver and Release of liability includes the right to use the premises (in addition to any fee for use) and sufficiency and adequacy of which are hereby acknowledged. Without signing this Release and Waiver, use of the Premises is not authorized.
